- No more than twelve (12) graduate units taken as a non-degree student may be eligible to apply toward an advanced degree awarded at the University of Arizona. It is important that you contact your future department concerning the acceptance and total number allowed of non-degree units.

### Residency:

### Propositions 300

Proposition 300 is a referendum approved by Arizona voters in November 2006. Proposition 300 provides that university students who are not U.S. citizens or permanent residents, or who do not have lawful immigration status, are not eligible for in-state tuition status or financial aid that is funded or subsidized by state monies. ### Immunization:

The University of Arizona requires verification of measles, mumps and rubella immunity for all students born after December 31, 1956. If you were born prior to December 31, 1956 you are exempt. Immunization records must be obtained from your health care provider indicating dates of:

- 1) Two (2) MMR immunizations, at least one of which must have been administered after December 31, 1979, OR**
- 2) A lab test that shows immunity to Measles, Mumps and Rubella.**

You will not be permitted to register for classes without proof of immunity against Measles, Mumps and Rubella on file with the Campus Health Service.

### Health Insurance:

Domestic students who are registered for classes at The University of Arizona do not need health insurance in order to access health care at the Campus Health Service (CHS). However, we strongly urge every student to maintain adequate health insurance to cover unexpected medical expenses.

**Attention International Students:** The University of Arizona requires that all international students, regardless of classification or number of units, carry the Student Health Insurance unless one qualifies for an exemption. Exemptions must be requested each semester.

## International Applicant Instructions and Information

The University of Arizona does *not* issue visa documents for non-degree studies. You must currently be in the United States on a visa that is valid for educational pursuits for the full length of time you wish to study. Please note that some visa types do not permit non-degree studies.

You must receive advising and visa status approval in person from the Graduate Admissions Office or the International Student Program Services (ISPS). **The non-refundable application fee is \$65.00 for International students** wishing to apply non-degree.

As a non-immigrant, you must satisfy the following requirements to be eligible for non-degree admission:

1. You must be in good standing with regard to your visa status.
2. If you are currently enrolled in study elsewhere, you must be in good academic standing at that institution.
3. If English is not your native language, you must submit evidence of a minimum TOEFL score of 550 PB or 79 iBT, taken within two years of your intended date of enrollment. This policy may be waived if you have completed two years of full-time upper division academic study or have received a bachelor's degree or higher from an institution in the U.S., English-speaking Canada, the United Kingdom, Australia or New Zealand within the past two years.
4. You must have earned a degree that is considered comparable to the U.S. bachelor's degree. You may be required to submit transcripts and/or degree certificates to verify eligibility for admission. The Graduate College will determine your eligibility based upon the educational background information you provide.
