Summary

In almost thirty years of progressively greater administrative responsibility in two professional categories I have developed the abilities to instruct and motivate others. My two professions have been social services in health care and library & information services. I have demonstrated expertise in supervision, collaboration, speaking and writing abilities. I have also developed an array of technical skills that serve to enhance my communication and put useful information online. I have provided bibliographic and Internet instruction to all levels of patrons: students, faculty, and community members. My thesis is research in the field of Native American Library services. I have trained and supervised library staff in the major domains of library administration; including archiving, cataloging, circulation, collection development, information technology, periodicals management, and reference work. As a health care social worker I provided services, taught medical and geriatric social work and supervised a staff of consultants. I provided consultative supervision to human service staffs in over 100 nursing homes in Florida. I am particularly proud of my ability to be a bridge between cultures. I think essential elements of this skill are an understanding and appreciation for different cultures and a respect for all people regardless of age, culture, or gender.

I mastered several applications to better manage the library and serve the patrons. These included circulation and cataloging software, both Netscape and Explorer, two word processing, database and spreadsheet programs, Power Point, and an electronic graphic organizer. I developed the fiction collection of both the elementary and secondary schools to correspond with the interests and reading levels of the students. I established a recreational reading program for both schools and participated in the inauguration of a nationwide reservation reading program, sponsored by ALA and the University of Texas at Austin, called; "If I can read, I can do anything!" I did my student teaching by developing a study skills curriculum for the study halls of the entire secondary school and creating a study skills video with two classes of advanced study skills students.
